### Explanation of Fees

For the purposes of this Schedule:

- **“Small Business”** means any business that has a gross annual revenue generated within the Kananaskis Improvement District of \$10,000 or less.
- **“Regular Business”** means any resident business that has a gross annual revenue generated within the Kananaskis Improvement District between \$10,000 and \$750,000.
- **“Major Business”** means any business that has gross annual revenue generated within the Kananaskis Improvement District of \$ 750,000 or greater.
